On September 6, 2023, our new contract was officially signed by AFSCME Council 31 Leadership, State Conference Board delegates, and the Governor's Representative. This final step was taken to fully implement the contract that members overwhelmingly ratified in July.

Now that the contract has been signed hopefully

CMS will finish reviewing the changes with all agencies and we will finally have full compliance with the changes. I know that at of this writing we are still having major problems with DHS not allowing workers to earn comp time for overtime instead of being paid in cash. There are several statewide grievances at 3rd level for this. I am also currently investigating an issue with EPA staff not receiving their remote work request back in a timely manner.

If you are having issues with or agency honoring new language in the contract, please let you steward or an executive bord member know right away.

By now all bargaining unit employees should have received their 4% increase and most have received their back ay as well. If you are still waiting for either of these please let Alice Sutherland know.

Part of the new contract language stipulates that the Union will not be responsible for having the contracts printed and the State will reimburse the Union for the cost of the printing. This was something we pushed really hard for since the last contract was delayed by at least 2 years because the state could not even get a vendor to bid on its printing. Going forward we will no longer have this problem so we should receive our hard copies of the contract very quickly. Right now Council 31 is just waiting for the print ready copy from CMS to get the ball rolling.
