AFSCME CALLS FOR PENSION FUND DIVESTMENT FROM ASSETS LINKED TO RUSSIA



Standing with the people of Ukraine against the brutal assault on their nation and their democracy, AFSCME Council 31 calls on public pension funds to take appropriate steps to divest all assets linked to Russia.

The union sent letters on March 7 to the Illinois State Board of Investment, which governs investment policy for the State Employees' Retirement System, as well as to other public pension funds in Illinois in which AFSCME members participate, calling for the prudent divestment of pension fund assets with ties to Russia.

"AFSCME strongly condemns Putin's shameful assault on the nation of Ukraine. Each of us must do our part to support the valiant resistance of the Ukrainian people in their struggle to protect their democracy," Council 31 Executive Director Roberta Lynch said. "This is truly a global emergency that compels all freedom-loving people of conscience to take urgent action to support the people of Ukraine."

Soon after, Brian Collins, executive director of the Illinois Municipal Retirement Fund, replied to AFSCME's letter, stating: "Please rest assured that we have been examining our portfolio for investments in Russia and will be discussing the matter with our full Board at our March 24-25 meeting."

Earlier in March, the AFSCME International Executive Board passed a resolution expressing our solidarity with the people of Ukraine, including the call for public pension fund divestment from assets linked to Russia.

"Ukrainians are demonstrating extraordinary courage and resolve in standing up to a violent autocrat," AFSCME President Lee Saunders said. "Their defense of their country is nothing short of inspiring. AFSCME's belief in human rights—wherever in the world they may be threatened—demands that we do what we can."

NO BAKE STRAWBERRY ICE BOX CHEESECAKE

Ingredients

- 2 pounds of strawberries, cleaned and dried off
- 20 ounces of cream cheese softened
- 3 cups of heavy cream
- 1 3/4 cups of powdered sugar
- 1 teaspoon of vanilla
- 1 (14.4 ounces) honey graham crackers

Preparation

- Rinse, [hull](#) and pat-dry your strawberries. Reserve whole berries for the top of your cake (about 16 small berries or 8 large berries) and slice the remainder.
- Using a stand mixer, or a large bowl with an [electric hand mixer](#), stir cream cheese until smooth.
- Gradually stir in about half of the heavy cream. Stir until smooth, pausing once to scrape down the sides of the bowl.
- With a mixer on medium-low speed, gradually add the remaining heavy cream.
- Increase speed to medium-high and beat until mixture begins to thicken (about one minute).
- Pause to scrape the sides and bottom of the bowl, and add powdered sugar and vanilla
- Stir again, gradually increasing speed to high. Beat until a thick, fluffy whipped cream texture is achieved.
- Cover the bottom of a 9 x 13-inch pan with an even layer of graham crackers (about 9 sheets—break graham crackers as needed to best fit).
- Spread about 1/3 of the cheesecake mixture evenly over the graham crackers.
- Place another layer of graham crackers over the cheesecake layer, evenly spacing as needed and gently nestle them into the first layer.
- Spread half of the remaining cheesecake over the graham crackers. Top with sliced strawberries, distributing strawberries evenly over the cheesecake layer.
- Evenly space another layer of graham crackers over the strawberries, using the graham crackers to press the strawberries snugly into the cheesecake layer.
- Top graham crackers with remaining cheesecake mixture and spread evenly.
- Cover and refrigerate at least 4 hours before serving. This will soften the graham crackers and give them a cake-like texture.
