TREASURER'S REPORT

Council 31 has a Spring/Forward Together initiative going on right now to get members together now that things are starting to open up. I know you have talked about different things, but I think it is really important to do something even if it is something small.

Jeff Bergstrom talked about re-opening email received from the Secretary of DHS

The FY22 state budget:

Averts layoffs in state agencies and funds scheduled pay increases.

Maintains state funding to local governments at current levels.

Provides funding for at least a \$1.50/hour wage increase for frontline workers in community disability agencies.

Closes several of the state's most costly corporate tax loopholes, saving hundreds of millions of dollars that help fund vital programs.

PRESIDENT'S REPORT: Alice Sutherland

Chris talked about most of the same stuff I was going to talk about but also the AFSCME legislative team **blocked passage of all bills seeking to reduce or eliminate public employee pension benefits**. These bills were either amended to address our concerns or were not called for a vote.

PRO (Protecting the Right to Organize) Act – is still out there. This would be a major win if it were to pass. There is still opposition out there of course so there are some targeted states that calls are being made to. If anyone would like to help with that effort get me your information and I will pass it on to Sara Dorner, President of Rockford United Labor, who is coordinating efforts in our area.

Apparently, there was a resolution passed last week in Illinois to open the Unemployment offices back up to the public. Nothing has been discussed with the IDES standing committee regarding this yet.

I was asked by a member at the Rockford Regional building today if I knew anything about DOC moving into their building. I have not been contacted at all about that. I don't know what part of DOC they were talking about. If it was DJJ or Parole, but either way I don't know if there is anything we could do to stop it. If it is DJJ that would really be better for us since they are already in our local and if it is Parole, we have been trying to get them into our local for years this would just be more leverage to do so.
